Description:

The attached financials are the unaudited financials as of April 30, 2024. The report is reflective of seven months (58.3%) of the fiscal year. Most <u>revenues should be tracking at 41.6% or lower</u>, indicative of revenues at or exceeding budget projections. Most <u>expenses should be tracking at 41.6% or higher</u>, indicative of expenses at or lower than budget projections. Overall, MDD revenues are tracking at 37.39% and expenses are tracking at 74.55% with expenditures exceeding revenues by \$804.89 for the month of April and revenues exceeding expenditures by \$215341.44 for the fiscal year to date.

It should be noted that that front summary sheet of the revenues versus expenditures has net Transfers In and Transfers Out of \$62,743.33 on both the revenue and expense side. This is reflective of journal entries made associated with transferring funds to a new financial institution. Since this did not change the actual dollars associated with the MDD Fund, it was removed from the summary sheet to provide a more accurate portrayal of the revenues and expenditures. Details of the transfer are included in the back up report.



Description:

At the February 8, 2024 meeting, the MDD voted to be a Gold Sponsor of the 2nd Annual Founder's Day in the amount of \$2,500.
