ORDINANCE # 2010-0712-01

AN ORDINANCE OF THE TOWN OF CROSS ROADS, TEXAS, AMENDING ARTICLE 12.05 (“SPEED REGULATIONS”) OF CHAPTER 12 (“TRAFFIC AND VEHICLES”) OF THE CODE OF ORDINANCES OF THE TOWN OF CROSS ROADS, TEXAS, TO ADD A NEW SECTION 12.05.004 REGULATING SPEED LIMITS BY ESTABLISHING A MAXIMUM SPEED OF 40 MILES PER HOUR ON NAYLOR ROAD AT ALL POINTS WITHIN THE TOWN’S LIMITS; PROVIDING A REPEALING CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND, PROVIDING AN EFFECTIVE DATE.
