#### **Description:**

The attached financials are the unaudited financials as of July 31, 2023. The budget versus actuals report represents the FY 23 adopted budget. The report is reflective of ten months (83.3%) of the fiscal year. Most <u>revenues should be tracking at 16.7% or lower</u>, indicative of revenues at or exceeding budget projections. Most <u>expenses should be tracking at 16.7% or higher</u>, indicative of expenses at or lower than budget projections. Overall, MDD revenues are tracking at 14.98% and expenses are tracking at 66.86% with revenues exceeding expenditures by \$32,100.67 for the month of July and \$320,057.27 for the fiscal year to date.





#### Prepared by:

#### Description:

The Board has previously taken action that requires an amendment to the FY 2023 budget, in addition to the need to adjust revenues to reflect reduced sales tax receipts.

#### FY 2023 ADJUSTMENTS:

- Decrease in Sales Tax Revenue based on YTD collections.
- Increase in Software based on actual expenses of sales tax reporting software.
- Increase in Administrative Expenses as authorized at the March 7, 2023 meeting to take on 33% of the Communications Coordinator position and increase the contribution towards the Town Administrator and Town Secretary's salary from 7% to 10% based on workload.
- Addition of \$20,000 allocated for MDD Business Grants as authorized at the June 8, 2023 Board meeting.
- The MDD may wish to consider utilizing some of their Advertising and Promotions funds to help sponsor the Town's Founder's Day Event.

Also included is the FY 2024 proposed budget for consideration and recommendation to the Town Council. Per Section 7.6 of the MDD bylaws, the Board shall adopt a proposed budget at least thirty (30) days prior to the commencement of each fiscal year which begins October 1<sup>st</sup>. The budget must also be approved by the Town Council. With the timing, the budget must be presented to the Town Council prior to their August 21<sup>st</sup> meeting.

At the June Council Retreat, the Council discussed initiatives they would like to see the MDD work on in the 2024 Fiscal Year. The memo from Council is attached for reference. The initiatives include increasing communication efforts with a heavy focus on Cross Roads businesses in the form of a monthly mailed newsletter compiled by Staff, continuing to utilize Mundo and Associates for business interviews, and hiring consultants related to Project Alpha and to perform a sales tax audit. The proposed Fiscal Year 2024 budget considers these initiatives.

#### FY 2024 PROPOSED BUDGET:

- Decrease in Sales Tax Revenue based on current collections.
- Increase in Interest Revenue based on current revenues.

- Increase in Rental Income per the property management company's recommended lease rate.
- Increase in Advertising and Promotion expenses to reflect the cost of monthly mailed newsletters at a monthly cost of approximately \$1,200 \$1,800 per month depending on the number of pages.
- Increase in Software to add an additional module to incorporate the boundaries of the MDD (Cross Roads ETJ) not just the Town limits.
- Increase in Administrative Expenses to reflect the full cost of the Communications Coordinator at approximately 16 hours per week; 10% of the weighted cost of the Town Administrator, Town Secretary and Accounts Payable Technician based on workload for a total of approximately \$57,500. This line item also includes approximately \$2,700 per year for the property management company for 1151 FM 424.
- Addition of Property and Liability Insurance for the property located at 1151 FM 424.
- Increase in Training and Travel to provide funds for a Basics of Economic Development Class for each member at approximately \$800/each; International Council of Shopping Centers (ICSC) Red River Conference at \$550/person (5 people); ICSC Las Vegas Conference at approximately \$2,500/person (2 people).
- Decrease in Planning/Consulting to \$50,000 with the expectation this would be used for services provided by Mundo & Associates, costs associated with Project Alpha and for a sales tax audit.
- Decrease in Rental Property Repair to \$10,000 based on current expenditures.

#### Recommended Action:

Recommend approval of the FY 2023 Amended Budget and the FY 2024 Proposed Budget.

TOWN COUNCIL MEMBERS

As you are aware, the Town Council conducted a planning retreat the first weekend of June. During that retreat, the Council had an opportunity to discuss projects and challenges each of the Town's boards are facing.

The Council came to a consensus with regard to items of interest to the Municipal Development District (MDD). The Mayor has committed to meet with the Council Liaison and Chairperson on a monthly basis to assist in moving projects forward.

General direction from the Council includes the following:

- Continue utilizing Mundo & Associates for business interviews.
- Increase communication efforts to assist businesses which includes the following:
  - Bringing the mailed newsletter in house and publish and mail on a monthly basis.
  - Seek advertising for the newsletter
  - Feature businesses in the newsletter and provide business highlights
  - The newsletter will be advertised as "Provided by the Cross Roads Municipal Development District"
  - Cover the full cost of the Communications Coordinator to coordinate the newsletter publication, website updates and general communication
  - The anticipated cost of the entire program is approximately \$30,000 per year
- Hire consultant related to Project Alpha to be detailed further at a future meeting.
- Pay for 10 temporary blue driveway signs.
- Engage a consultant to perform a sales tax audit.
- Re-evaluate the installation of a digital sign in three years.
