Whereas, a certified copy of said order, together with the plat of the town was duly and legally recorded and entered of record in the proper record of deeds of Denton County;

THEREFORE, BE IT KNOWN, that I, Tom Todd, County Judge of Denton County, Texas, do hereby order an election to be held on the 14 day of July, 1973, at the property owned and occupied by LARUE LUDWIG, within said Town of Cross Roads, for the following purposes and none other:

ELECTING A MAYOR, A TOWN MARSHAL AND FIVE ALDERMEN FOR THE SAID TOWN OF CROSS ROADS, TEXAS, SAID OFFICERS TO HOLD OFFICE UNTIL THEIR SUCCESSORS HAVE BEEN ELECTED AT THE NEXT SUCCEEDING ANNUAL ELECTION.

Applications by candidates for office to have their names placed on the ballot shall be made to me by filling out such application as is prescribed by law and returning the same, along with the statutory filing fee, to Dorothy Turner, at the Turner & Ottinger Store, no later than 5:00 P.M. on the 29th day of June, 1973. After such time, and such notice as is required by law, the Presiding Judge of said election shall conduct a drawing for places on the ballot, in accordance with Art. 6.05c of the Texas Election Code.
